

## Suggested Format for Indicator-Led Analysis in the SAI Performance Report (Chapter 4)

The following format may be used to write the indicator-led analysis. One should complete a section like this for each of the 25 indicators. The first table provides a very short summary of the indicator, and more detail is provided for each dimension below.
